## PROCEDURES AND DEADLINES FOR SUBMITTING AN APPLICATION FOR ENROLMENT INTO MASTER'S DEGREE STUDY PROGRAMMES IN THE ACADEMIC YEAR 2026/2027

### ENROLMENT PLACES

The number of available enrolment places for enrolment for each master study programme is announced under the individual study programme in the Call for enrolment. Enrolment places are announced separately for citizens of the Republic of Slovenia and citizens of the Member States of the European Union (hereinafter: Slovenian citizens), Slovenians abroad, citizens of Western Balkans countries, with which the Republic of Slovenia has a bilateral agreement in the field of education (Bosnia and Herzegovina, Montenegro, Kosovo, Serbia, North Macedonia)<sup>1</sup> and citizens of other non- European Union countries.

Applicants for places allocated to Slovenian citizens may also include citizens of non- European Union countries (hereinafter: foreign citizens) who have permanent residence in Republic of Slovenia, and citizens of non- European Union countries who have permanent residence in Republic of Slovenia and who themselves, or at least one of their parents or legal guardians, are tax residents of the Republic of Slovenia prior to the start of the selection procedure.

The available places are also intended for persons granted international protection and applicants for international protection in accordance with the International Protection Act (Official Gazette of the RS, No. 16/17 – consolidated text and 54/21), and for displaced persons under temporary protection in accordance with the Temporary Protection of Displaced Persons Act (Official Gazette of the RS, No. 16/17 – consolidated text).

Nationals of the following non-EU Member States: Norway, Iceland, Liechtenstein, and Switzerland shall be treated in the same manner as Slovenian nationals and nationals of the European Union. From the academic year 2021/2022 onwards, nationals of the United Kingdom shall be enrolled as nationals of non-EU Member States, and their studies shall be subject to the payment of tuition fees.

### APPLICATION FOR ENROLMENT

Candidates for enrolment in master's study programmes at the University of Primorska (UP) may submit a **maximum of three (3) applications** (with one study wish each) for enrolment into study programme, in which they wish to enrol and for which they meet or will fulfil the conditions for enrolment (admission requirements) by the deadlines published with this Call. Every completed submission of an electronic application in the eVŠ web portal is considered an application.

#### Enrolment places for Slovenians abroad

<sup>1</sup> A Protocol in the field of education with the Republic of Albania regarding exemption from tuition fees for full-time study for Albanian nationals is currently being prepared. Nationals of the Republic of Albania shall submit applications for enrolment to the study places intended for foreign nationals from non-EU Member States. If the protocol in the field of education is adopted by the beginning of the academic year 2026/2027, nationals of the Republic of Albania shall be exempt from paying tuition fees for full-time study, subject to the principle of reciprocity.

Slovenians abroad may submit only one application in the same application period, either as a “Slovenian abroad” or as a “citizen of a European Union Member State” or a “foreigner from a non-European Union country”.

At the first step of filling the application for enrolment ("Choice of the call for applications for enrolment and types of application"), a candidate, who is a Slovenian abroad, answers with "YES" to the statement "I am Slovenian abroad". At the next step, they must indicate which of the following two categories they fall into:

- Slovenians in the neighbouring countries (Slovenians who are members of the ethnic Slovenian community in all four neighbouring countries – Italy, Austria, Croatia and Hungary);
- Slovenians around the world and descendants of persons of Slovenian ethnicity up to the third generation in a direct line (expatriates and emigrants living in the neighbouring countries outside the area defined as the Slovenian cross-border area and in other European and non-European countries)

By signing the application form, the candidate guarantees the truthfulness of the information stated in the application for enrolment, thereby confirming that they are a Slovenian abroad, which means that they fall into one of the two categories listed above.

## APPLICATION FOR ENROLMENT

Candidates for enrolment into master study programmes at the UP submit an electronic application at the eVŠ web portal <https://portal.evs.gov.si/prijava> by means of **electronic identification of at least assurance level substantial (with a qualified digital certificate, an smsPASS or an e-identity card), with an AAI-account** (authentication and authorisation infrastructure account), or with a **user name and password via the SI-PASS system**<sup>2</sup> which operates as part of the Trust Service Authority of Slovenia.

**After the application has been submitted successfully**, the applicant receives confirmation that the submission has been successful at the email address provided in the application for enrolment. **If the candidate does not receive the confirmation, the application has not been successfully submitted.**

**In the application and admission procedures for the 2026/2027 academic year, applicants submit all proof required for the application electronically via the eVŠ portal.**

The application is considered **submitted on time** if it was completed and submitted online with an electronic signature via the eVŠ web portal by the deadline specified in the Call for enrolment.

Applicants are required to check the e-mail address provided in the application for enrolment and the eVŠ web portal, as the communication and possible invitations to complete the application for enrolment are conducted in this manner. **Applicants must themselves ensure the validity of the e-mail address provided in the application.**

Faculties UP shall serve or make available to applicants the documents and notifications relating to the call for enrolment by depositing the document or notification in the eVŠ portal (in accordance with Article 57 of the Higher Education Act). Documents and notifications shall be served or made available to applicants by depositing them in the eVŠ portal in accordance with Article 57 of the Higher Education Act. Applicants shall be informed of the deposit of a document or notification via the eVŠ portal by means of an informational message sent to the email address provided in the application and, if provided, by a message sent to their mobile phone number. Applicants shall retrieve the document or notification from the eVŠ portal in electronic form following prior authentication. Upon personal service

of a document via the eVŠ portal, the applicant shall electronically confirm the electronic proof of service. The date of electronic confirmation of the electronic proof of service shall be deemed to be the date of service of the document. If the applicant does not retrieve the document within five days of receiving the informational message regarding the electronically deposited document in the eVŠ portal, service shall be deemed to have been affected upon expiry of that period.

#### EVIDENCE OF FULFILMENT OF THE ENROLMENT CONDITIONS

**Scanned documents or photographs of original certificates** and other required documents are considered as evidence that the enrolment conditions in the application and admission procedure have been met. Candidates are required to submit all the necessary attachments to the applications **electronically through the eVŠ web portal**. The required documents (evidence of fulfilment) that the candidate must enclose with the application for enrolment are stated in the Call for enrolment of the faculty that implements an individual study programme.

#### INFORMATION ABOUT MANDATORY INTERVIEW WITH CANDIDATES FROM COUNTRIES WITH HIGHER MIGRATION RISK - ENROLMENT IN THE ACADEMIC YEAR 2026/2027

Based on the [Higher Education Act](#) (Official Gazette of the Republic of Slovenia, No. 56/25; Article 13) Higher education institutions must conduct a direct interview, prior to any further academic and administrative processing of the application, with a foreign national who has submitted an application for enrolment in higher education studies in the Republic of Slovenia and who comes from one of the countries with higher migration risk, as defined by the [list of countries](#) whose citizens are required to hold visas when crossing the external borders of the European Union, in accordance with the law governing the conditions and methods of entry, exit, and residence of foreigners in the Republic of Slovenia. The purpose of the interview is to assess the suitability of such a candidate with regard to the enrolment requirements of the study programme.

#### Interview invitation and procedure

The candidate for enrolment at the University of Primorska (UP) will receive an invitation to the interview at the email address provided in the enrolment application submitted via the eVŠ information system.

The interview will be conducted in English by an appointed committee via the ZOOM information platform.

At the scheduled time (date and time according to CET) specified in the interview invitation, the candidate joins the interview via the ZOOM link provided in the invitation.

#### Obligation to pay the interview fee

Within five (5) days after submitting the enrolment application, the candidate is required to pay **200.00€** to the UP to cover the costs of conducting the interview, in accordance with the Price List for conducting interviews pursuant to the provisions of the Higher Education Act (ZViS-1) for candidates – citizens of countries with higher migration risk applying for enrolment in study programmes of the University of Primorska in the academic year 2026/2027 ([link eng](#))

The payment must be made by payment card via the payment link: [interview payment](#).

The interview fee is non-refundable regardless of the interview result. The fee will also not be refunded in the case the candidate does not attend the interview.

## Interview result

The candidate will be informed of the interview result within three (3) working days after the interview has been conducted.

A candidate who **successfully completes** the interview will receive an email notification, sent to the email address provided in the enrolment application, confirming that the interview has been completed and that their application will proceed to further processing. In the subsequent procedure, it will be verified whether the candidate has submitted all required supporting documents in accordance with the Call for enrolment and whether they meet the enrolment requirements for the study programme(s) stated in the application. If the application is complete and the candidate meets the enrolment requirements, the application will be included in the ranking procedure. If the candidate achieves the required number of points for admission, a decision will be issued confirming their admission to the relevant study programme. Otherwise, a rejection decision will be issued, regardless of the fact that the interview was successfully completed.

A candidate **who does not pass the interview** because UP has justified grounds to suspect that the candidate does not demonstrate the knowledge in accordance with the documents submitted within the application **will receive a rejection decision, by which all procedures related to their enrolment application are fully terminated. No appeal is permitted against this decision.**

If a candidate fails to pay the interview fee within the prescribed deadline or does not attend the interview, UP will issue a decision rejecting the application. By such rejection decision, all procedures related to the candidate's enrolment application are fully terminated. No appeal is permitted against this decision.

**Attention:** This Interview Protocol does not apply to candidates who, at the time of submitting their application for enrolment in the eVŠ information system, hold a permanent or temporary residence permit in the Republic of Slovenia. #### PARALLEL STUDIES

Students can apply for enrolment in parallel studies. Candidates follow procedures and deadlines as described in the section »APPLICATION FOR ENROLMENT«. All the necessary documents are stated in the call for enrolment of the Faculty that implements an individual study programme.

#### APPLICATION FOR ENROLMENT IN A HIGHER YEAR OF STUDY (ACCORDING TO THE TRANSFER CRITERIA AND CONDITIONS FOR ACCELERATED ADVANCEMENT)

Candidates can apply for enrolment in the second study year according to transfer criteria between study programmes and conditions for accelerated advancement. Candidates are required to apply as described in the section »APPLICATION FOR ENROLMENT«. Available places and all the necessary documents are stated in the call for enrolment of the Faculty that implements an individual study programme.

#### NOTICE FOR ENROLLED STUDENTS

Students who want to change the study programme and have not yet exercised this right or the right to repeat it must apply in the same manner as other candidates. This also applies to students who want to change the manner in which they study in the same study programme in the first year. Both submit the application for enrolment on the eVŠ web portal (<https://portal.evs.gov.si/prijava/>).

Candidates who **have already repeated or changed their study programme once** may apply for full-time studies, although their studies are subject to a tuition fee in accordance with Article 137 of the Higher Education Act.

Candidates who want to repeat the first year of the study programme in which they enrolled in previous years do not submit the application for enrolment via the eVŠ portal. In order to be re-enrolled in the same year of the study programme in which they are already enrolled, candidates must meet the conditions for a repeat year. Students receive information on the procedure and conditions of enrolment for a repeat year at their faculty. This also applies to advancement to a higher year in the study programme in which the candidate is already enrolled.

Candidates can also apply to the same study programme in which they had already been enrolled and have signed out. The studies referred to in the previous sentence are subject to a tuition fee (Paragraph 7, Article 137 of the Higher Education Act). For more information, applicants can contact the faculty.

#### PROCEDURE FOR RECOGNITION OF EDUCATION FOR THE PURPOSE OF CONTINUING STUDIES IN THE REPUBLIC OF SLOVENIA FOR CANDIDATES HOLDING A FOREIGN EDUCATION CERTIFICATE

A candidate who has completed their education **abroad** demonstrates the fulfilment of the conditions for enrolment with a document obtained abroad, which is subject to recognition under the Assessment and Recognition of Education Act (Official Gazette of the RS, Nos 87/11, 97/11 – corr. and 109/12).

In this case, candidates are required to apply for enrolment as described in the section »APPLICATION FOR ENROLMENT«. The electronic application for enrolment is also an application for the recognition of education for the purpose of continuing education in the Republic of Slovenia. The application must be submitted via the **eVŠ on the web portal**: <https://portal.evs.gov.si/prijava/?lang=en>

A candidate who submits an incomplete application for enrolment or an application for recognition of education for the purpose of continuing education will be individually additionally informed about the request and deadline for the completion of the application electronically via the eVŠ portal. The candidate will download the document or the notification from the eVŠ portal in electronic form after prior authentication. The candidate is deemed to have been informed of the content of the document or notification by logging in to the eVŠ portal. When the document is delivered in person via the eVŠ

web portal, the candidate shall electronically validate the electronic delivery form. The date of the electronic confirmation of the electronic service of the document referred to in the previous sentence shall be deemed to be the date of service of the document. If the document is not collected by the candidate within five days of the date of receipt of the information message on the electronically deposited document on the eVŠ portal, service shall be deemed to have been affected on the day on which this period expires.

- ✓ Candidate who **has already obtained a decision** of recognition of foreign education is required to submit the decision to the application electronically via the eVŠ web portal.
- ✓ For a candidate with a foreign certificate in education, who **does not yet have a decision on recognition of education**, the application for enrolment is also considered as an application for the recognition of foreign education via the eVŠ web portal: <https://portal.evs.gov.si/prijava/?lang=en>

**NOTE**

The **deadline for the issuing of a decision recognition** in accordance with the Assessment on the Evaluation and Recognition of Education Act (Official Gazette of the Republic of Slovenia, No. 87/2011, 97/2011 am. and 109/12) is no later than **two months after the application has been completed**.

Candidates must comply with the deadlines set for the submission of proof of compliance with the enrolment conditions in the application and admission procedure. Applications that are not completed by the deadline in accordance with the call for completions will be rejected in accordance with the General Administrative Procedure Act and applications will not be included in the selection procedure.

**ENROLMENT LIMITATION AND SELECTION CRITERIA**

If the number of candidates in the individual study programme exceeds the number of enrolment places, the enrolment limit is considered to be the number of places advertised. In this case, candidates will be selected in the selection process.

**SELECTION CRITERIA** (in the case of enrolment limitations) are determined by the individual study programme and are published in the Call for enrolment. Information on study programmes, on which the enrolment limitations will be applied, will be published on the website of each faculty.

## DECISION ON SELECTION AND ADMISSION PROCEDURE

The decisions of the selection procedure will be published on the eVŠ web portal. The candidate can access the decision on the result of the selection procedure on the eVŠ portal (<https://portal.evs.gov.si/prijava/> with their user account). The candidate will download the document or the notification from the eVŠ portal in electronic form after prior authentication. The candidate is deemed to have been informed of the content of the document or notification by logging in to the eVŠ portal. When the document is delivered in person via the eVŠ web portal, the candidate shall electronically validate the electronic delivery form. The date of the electronic confirmation of the electronic service of the document referred to in the previous sentence shall be deemed to be the date of service of the document. If the document is not collected by the candidate within five days of the date of receipt of the information message on the electronically deposited document on the eVŠ portal, service shall be deemed to have been affected on the day on which this period expires.

## ENROLMENT IN THE STUDY PROGRAMME

The faculty will invite admitted candidates to enroll in the study programme. The candidate will receive instructions, deadlines and other important information regarding the enrolment and beginning of the study year.

**The enrolment** in study programmes must be **concluded by 30 September 2026**. Competent commission can grant an extension for justified reasons but not later than 30 October 2026, based on a candidate's request. Regardless of the justified reason, the candidate must submit the application for enrolment in the eVŠ by the deadline set in the Call for enrolment.

It is considered that a student who, after the first enrolment in the first year of a master study programme, signs out by 15 October 2026 has not enrolled in this study programme.

## TUITION FEES

Tuition fees and other study fees for the academic year 2026/2027 are determined in the Pricelist of the University of Primorska - 2026/2027, accepted by the Managing Board of University of Primorska. The Pricelist is published on the websites of the University and each Faculty.

Citizens of the Republic of Slovenia and citizens of the European Union may not be required to pay a tuition fee for full-time study as part of master study programmes with public validity that are performed as a public service.

Notwithstanding the previous paragraph, citizens of the Republic of Slovenia and citizens of the European Union are charged a tuition fee if they have already acquired education that corresponds to at least the level of education acquired under the study programme in which they are enrolled.

Under the same conditions as Citizens of the Republic of Slovenia (without payment of tuition fees for full-time study), the following may also pursue for:

- Slovenians abroad;
- foreign citizens of non-European Union countries who have completed upper secondary education in the Republic of Slovenia and passed the matura examination;
- foreign citizens of non-European Union countries who have permanent residence in the Republic of Slovenia and who themselves, or at least one of their parents or legal guardians, are tax residents of the Republic of Slovenia prior to the start of the selection procedure;
- person granted international protection, applicant for international protection, and displaced person under temporary protection;
- citizens of the following non-European Union countries: Norway, Iceland, Liechtenstein, and Switzerland.

On the basis of the signed protocols on cooperation in the field of education, citizens of Montenegro, Kosovo, North Macedonia, Bosnia and Herzegovina and Serbia are on an equal footing with citizens of Slovenia and citizens of EU Member States with regard to the payment of study costs for the 2026/2027 academic year, i.e. they are exempt from the tuition fees for foreign citizens for full-time studies.

Tuition fees are also charged to candidates who have not yet obtained an education corresponding to at least the level of education acquired under the study programme in which they are enrolled and who have already exercised the right referred to in the second or third indent of the first paragraph of Article 111 of the Higher Education Act (i.e. they have already changed their study programme or field of study, or repeated any year at the same level of study), unless they enrol in a higher year than the one in which they were previously enrolled at the same level of study.

Candidates who have already repeated a year once or have already changed their study programme once may apply and be admitted to full-time study; however, tuition fees are payable for their studies in accordance with Article 137 of the Higher Education Act. Tuition fees are not charged only if the student enrolls in a higher year than the one in which they were previously enrolled at the same level of study.
